

## <u>Upgrading a Parallels Remote Application Server license to version 15 and higher</u>

- Parallels Remote Application Server 14.0
- Parallels Remote Application Server 12.0

A Parallels business account is required to manage the Remote Application Server license. When upgrading to Parallels Remote Application Server version 15.x and higher, the license information will be migrated to the <u>Parallels Business Account Portal</u>. This will replace the old <u>2X Partner-Relationship-Management (PRM) System</u> which was used for Remote Application Server legacy versions.

To upgrade the license to v15.x and higher, follow these steps:

- 1. If you are running a legacy version of Parallels Remote Application Server (i.e. v14.1 and lower), download and install the newer Remote Application Server version (v15.x onwards)
- 2. Upon start-up, Remote Application Server v15.x/ v16 prompts the Administrator to log in to an existing or create a new Parallels business account.
- 3. After successful sign-in or sign-up, the license information requires re-validation and migration. This process starts automatically.
- 4. The migration procedure in Remote Application Server v15.x/ v16 runs automatically and does not require any user intervention.
- 5. Upon completion of the migration process, you can view your new subscription assets in the **Subscriptions** and **Licenses > All Subscriptions > Subscription** details page of the <u>Parallels Business Account Web Portal</u>.
  - ♦ Auto-renewal status: Non-renewable
  - ◆ Expiration date instead of Next billing date
  - ♦ Disable/Enable auto-renewable is not available
  - ♦ Upgrade Support Level is not available
  - ♦ Changing the number of licenses (adding more licenses) is not possible
  - ♦ Displaying Order History is not possible
  - ♦ Changing Payment Option is not possible
  - ♦ Sublicenses Enabled
  - ♦ Renewal fee N/A
